The Adopter and TNR Trust Nairobi agree to the following terms and conditions:

1. TNR Trust Nairobi recommends taking the Animal to the veterinarian within one week of the date of this contract for a physical exam. TNR makes no guarantees as to the health of the Animal.
2. The Animal shall be kept on dewormer and flea/tick prevention 12 months a year.
3. The Adopter shall have the Animal spayed or neutered no later than the date specified herein if applicable. Title and ownership of the Animal shall not pass to the Adopter until a spay/neuter certificate from a locally based licensed veterinarian is provided to: [admin@tnrtrust.org](mailto:admin@tnrtrust.org). The animal cannot be taken abroad before the neuter certificate has been received by the Trust.
4. The Adopter shall provide the Animal with humane care as per the law. The Adopter agrees that it is illegal to confine a dog in a box.
5. The Adopter shall provide the Animal with necessary veterinary care in the event of sickness disease or injury. The Adopter shall take the Animal to a licensed veterinarian once a year for routine vaccinations.
6. The Adopter shall provide the Animal with a fully fenced yard and/or other humane means of exercise. The Animal shall not be tied or chained outside/inside for any reason. It will have access to a dry and adequate sized shelter. TNR recommends the dog sleeps inside at night for the security of the Adopter and the safety of the Animal (poisoning of dogs is a reality in Kenya).
7. If, for any reason, the Adopter cannot keep the Animal, the Adopter shall make every effort to find a home of similar standards. TNR may be engaged to mediate if the Adopter fails to find a suitable home. The Adopter agrees not to leave the Animal with domestic staff or abandoned upon relocation.
8. The Adopter agrees the Animal will not be sold, traded or used for fighting sports or breeding. The Adopter further agrees that the Animal will not be used for vivisection or any experimental purpose whatsoever.
9. The Animal shall reside at the address shown to TNR at the time of adoption.
10. The Adopter shall keep the Animal as a household pet. The Animal shall be subjected to humane training devices and methods only. Electronic prongs and choke chains are not permitted. At all times, the correct treatment of the animal is subjected to the [Prevention To Animal Cruelty Chapter 360](#) and where it is silent or unclear subject to the Trust's acceptable Standards.
11. The Adopter, from the date of this contract, agrees to release and indemnify TNR from any and all claims, known and unknown, now or hereafter arising in connection of the Animal.
12. The Adopter specifically acknowledges and consents to TNR conducting a house check after the adoption and/or examination of the Animal at any time. The Adopter also consents to reclamation of the Animal by TNR at any time for failure to comply with the terms and conditions of this contract or for any misrepresentation of fact made by the Adopter.
13. The Trust will contact you via e-mail or telephone regarding the adoption or house visit.
